## EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

## ITEM NO.3:

Mr. Amit Nandkishore Garg (DIN: 00537267) is currently an Independent Director of the Company and Chairperson of the Audit Committee and Stakeholder's Relationship Committee of the Company. He was appointed as an Independent Director of the Company on 8<sup>th</sup> September, 2014 for a period of five consecutive years w.e.f. 8<sup>th</sup> September, 2014.

Mr. Amit Nandkishore Garg is eligible for re-appointment for a second term on the Board of the Company as an Independent Director, not liable to retire by rotation, effective from  $8^{th}$  September, 2019 to  $7^{th}$  September, 2024, subject to the approval of the Members by a Special Resolution. Based on the recommendations of the Nomination and Remuneration Committee, the Board of Directors proposes the re-appointment of Mr. Amit Nandkishore Garg as an Independent Director of the Company. The Company has, in terms of Section 160(1) of the Act, received a notice from a member proposing his candidature for the office of a Director.

The Nomination and Remuneration Committee and Board of Directors at their meetings held on 27<sup>th</sup> July, 2019 on the basis of the report of performance evaluation of Independent Directors and considering his rich experience and expertise in accounts, finance and corporate matters and his valuable contribution to the Company, have recommended the re-appointment of Mr. Amit Nandkishore Garg as an Independent Director for a further period of 5 years from 8<sup>th</sup> September, 2019 to 7<sup>th</sup> September, 2024.

As per Section 149 of the Act, an Independent Director can hold office for a further period of 5 (five) consecutive years on the Board of the Company and he shall not be included in the total number of Directors for retirement by rotation.
